#### **GROUP WATERFRONT POLICIES**

In order to insure adequate supervision for any persons engaging in waterfront activities <u>and</u> to protect the waterfront equipment, the following policies have been adopted by the Outdoor Ministries Committee.

- <u>USE OF CAMP WATERCRAFT</u>: Any picnic, camping or retreat group wishing to use the camp watercraft must check in with the camp resident manager upon arrival to review safety rules.
   \*<u>Proper adult supervision is required at all times</u>. At the conclusion of their waterfront time, the group will check out with the resident manager who will see that all equipment has been properly stored and is in good condition. <u>The group will be responsible to pay for any equipment that was damaged</u>. Lifejackets must be worn by all watercraft users.
- <u>USE OF PRIVATE WATERCRAFT</u>: Any picnic, camping or retreat group wishing to use privatelyowned watercraft must check with the camp resident manager prior to arrival. \*<u>Proper adult</u> <u>supervision is required at all times</u>.
- <u>SWIMMING</u>: Any picnic, camping or retreat group wishing to swim in camp facilities must check in with the camp resident manager upon arrival to review safety rules. Each group will assume responsibility for their own members during swimming as the camp cannot provide any lifeguard personnel. \*<u>Proper adult supervision is required at all times</u>. (Use of the pool at Lutheran Hills is from three days prior to the first day of summer camp to the Sunday after the last day of summer camp.)

In the opinion of the Resident Manager or Summer Camp Director, if there is insufficient or inadequate adult supervision, the group's privilege of using waterfront – either watercraft or swimming – may be suspended <u>IMMEDIATELY</u>.

If your group intends to make use of any waterfront activity during your stay at Lake Luther, Lutheran Hills, or Lutherwald, please complete the section on the back and return it to the Outdoor Ministries office. <u>Your group must have completed and filed a reservation form prior to your stay to utilize the waterfront</u>.

\* Lutheran Outdoor Ministries recommends that "proper adult supervision" be a certified lifeguard.
